Fees are due and payable in advance on approval of your application and thereafter on April 1st each year. Members who have not paid their fees within 60 days of the due date, or made a payment arrangement with the Club's Treasurer, will be deemed to have resigned their membership.

New members joining will pay the prescribed annual fees pro rata per three months of membership as follows; Apr 1st to Jun 30th = 100%; Jul 1st to Sept 30th = 75%; Oct 1st to Dec 31st 50%; Jan 1st to Mar 31st = 25%.

A Bowls WA clearance fee will be required to be paid by all pennant players transferring from another club.

Clearances are not granted by Bowls WA after 31st December in each pennant season.

Ordinary Member **\$285.00**

Ordinary Members are afforded use of all amenities in the clubrooms, may play for our Club in Bowls WA pennant competitions, our Club championships and associated events or represent the Club in any event away from the Club's own greens. Ordinary members may hold office in the Club and may speak or vote in any meeting, on any matter affecting the Club.

Restricted Member **\$170.00**

Restricted Members are afforded use of all amenities in the clubrooms and are entitled to use the greens at Leeming Bowls and Recreation Club only. Restricted Members cannot play for our Club in Bowls WA pennant competitions, our Club championships and associated events, or represent the Club in any event away from the Club's own greens, unless specific approval is given by the Club Executive. Restricted Members are not eligible to hold any official position in the Club, or speak in any meeting or vote on any matter affecting the Club.

Junior Member **\$80.00**

Junior Members are persons under the age of twenty one (21) years who may play for our Club in Bowls WA pennant competitions, our Club championships and associated events, or represent the Club in events away from the Club's own greens. Junior Members may only enter areas of the Club's premises, or use the facilities of the Club as and when directed by the Executive, and in accordance with the provisions of the Liquor Act. Junior Members are not eligible to hold any official position in the Club, or speak in any meeting or vote on any matter affecting the Club

- The Secretary is required to post your application on the notice board at the Club for at least fourteen (14) days prior to its consideration by the Executive, therefore, it will be available for all members to view in that time

- If your application is accepted, your details will also be registered with Bowls WA.
